

### United Airlines Ski & Snowboard Club Waiver

I acknowledge and represent that my participation in the United Airlines Ski & Snowboard ("Club") is completely voluntary. I AM AWARE AND ACKNOWLEDGE THAT I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH MY KNOWLEDGE OF THE DANGER INVOLVED AND I HEREBY AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS OF INJURY, DEATH, OR PROPERTY DAMAGE. I also agree to conduct myself in a safe and prudent manner while participating in Club Activities, and I hereby absolve and hold harmless the Club, United, and each of their respective officers, directors, employees, agents, successors, and assignees from any damage or injury I may sustain while participating in the Club or Club Activities, including, but not limited to, any damage or injury resulting from a breach of any of these representations.

I agree to make my own arrangements at my own expense for insurance coverage in the event I choose to cover any losses that may be incurred as result of Club participation and Club Activities. Neither the Club, United, nor any of their respective officers, directors, employees, agents, successors, or assignees, have any liability whatsoever in the event that I am injured and/or incur a loss of property in connection with participation in the Club or Club Activities.

I, for myself, my heirs, executors, administrators and representatives, do hereby agree to release, discharge, and hold harmless the Club, each of its respective officers, directors, employees, agents, successors, and assignees ("Club Sponsors"), United, and each of United's respective officers, directors, employees, agents, successors, and assignees, as well as any cooperating organizations or any other parties connected in any way with activities sponsored or promoted by the Club, individually and collectively, from and against any liability for any death, injury, harm, loss, inconvenience, claim, cause of action, or any other damage of any kind whatsoever (including any death, injury, harm, loss, inconvenience or other damage caused by the negligence or other acts of Club Sponsors), including any costs or expenses arising out of any liability, which may result from or be connected in any way with my participation in Club Activities.

I hereby agree to defend and indemnify the Club, Club Sponsors, United in addition to each of their respective officers, directors, employees, agents, successors, and assignees (hereinafter jointly referred to as the "Indemnitees"), for any and all claims, causes of action, damage judgments, costs or expenses, including attorneys' fees, that in any way arise from Club Activity or this waiver agreement, including but not limited to damages to or destruction of any property of the Indemnitees or any others, injury or death of the undersigned or anyone else, or any liability arising from the act or negligent act of the indemnitees, the undersigned or anyone else.

I hereby consent to and permit emergency treatment in the event of injury or illness while participating in Club Activities. I also hereby give permission to the Club and United to use my name and any pictures/video taken of me during these events in any promotional materials, publications, or on the Internet.

Notice: Waivers/Releases of participants under the age of 18 must be signed by a parent or legal guardian. Any participant under the age of 18 must also be accompanied by an adult (21 or older).
